

State Police Called After Mannequin Masquerade

The Pennsylvania State Police were called after two students from Pocono University masqueraded as mannequins at the Main Street Dress Your Best shop on Saturday.

The students, Jeffrey Ruffio 21, and Kala Hughes, 20, were posing as a couple in one of the displays for at least fifteen minutes before jumping out and frightening several customers, including Mrs. Samantha Black and Mayor Margo Truelove.
